Section 1: Affiliation Fees

Greater Illawarra Cricket Zone Annual Association Affiliation Fee: **\$1000.00.**

Section 2: Team Registration Fees

The following team registration fees are applicable to affiliated associations for teams entered the Greater Illawarra Cricket Zone Intra Zone Competition:

Section 3: Player Registration Fees

3.1 Intra Zone Competition

There will be no player registration fee payable for players participating in the Intra Zone Competition. The Intra Zone Competition teams are as outlined in Section 2.

3.2 NSWDCAs/Youth Championships Competition

Players playing on behalf of the Greater Illawarra Cricket Zone in the NSWDCAs/Youth Championships competition will be subject to the following player registration fee:

3.3 Country Cricket NSW Competitions

Players playing on behalf of the Greater Illawarra Cricket Zone in other Country Cricket NSW competitions will have no player registration fee payable.

Section 4: Player Payments and Financial Entitlements

4.1 Player Payments

Under no circumstances are players paid by the Greater Illawarra Cricket Zone to play cricket. Player Entitlements may be paid at a rate to be determined by the GICZ Executive from time to time.

4.2 Financial Entitlements for Team Officials

Team Officials for the Greater Illawarra Cricket Zone will receive entitlements to cover the cost of expenses imposed upon them in their duties. Entitlements vary based upon the location and duration of the competition that the zone team is participating in. These allowances are not paid for matches and cricket events undertaken inside the boundaries of Greater Illawarra Cricket Zone. The following is a guide of official entitlements that are to be paid by the Greater Illawarra Cricket Zone:

Officials Entitlement	Officials Payment
Travel Allowance (Only paid to the driver, for private vehicle only)	\$0.40/km
Meal Allowance (Only if official stays with the team)	\$25.00/day
Accommodation Allowance (Only if official stays with the team)	\$60.00/day

Section 5: Game Day Expenses

Game Day Expenses allowances are self-explanatory and are only applicable to Greater Illawarra Cricket Zone Teams, excluding NSWDC & Youth Championships Competition teams. They include but are not limited to equipment, drinks, lunches, and other required items or services that are required on game day for cricket to take place. Game Day expenses must be accounted for by the team manager and receipt of purchases for Game Day Expenses must be presented to the Finance Committee.

An upfront payment for game day expenses will sometimes be made to the manager prior to the match or carnival however if expenses are less than the upfront payment, the remainder of payment must be paid back to the zone. If the upfront payment is less than the total cost, the zone will pay the difference after the match or carnival. The common payment to Team Managers for Game Day Expenses allowances for Greater Illawarra Cricket Zone is **\$100.00**. If a higher allowance is required for game day expenses, the Team Manager must contact the finance committee at least 24 hours before to confirm that a higher allowance is required and hand receipts in within 14 days.

NOTE 5.1: Game Day Expenses do not include expenses for competitions stated in Section 6.

Section 6: Ground Use / Lunch / Drinks Allowance

Ground Use / Lunch / Drinks Allowance are paid to the hosting association for Intra Zone or Team Manager for Country Cricket NSW competitions. The following schedule outlines the allowance paid to the hosting association/team manager for each applicable playing day of a competition:

NOTE 6.1: GICZ May supply Lunches for competitions by its discretion. **As of Season 2020-21, A Catering Allowance will no longer be paid to associations under any circumstance. Ground Allowances paid to associations must be paid to the ground authority/curating club in its entirety.**

Section 7: Zone Team Official Honorariums

Zone Team Officials are for select representative competitions, paid an honorarium for their service to the zone. In addition to their honorarium, all below Zone Team officials will receive free supplied apparel (Polo shirt, Training Shirt, Shorts & Cap) upon their first appointment to an official's role. As a guide, team officials are paid the following amounts for the respective competitions:

NOTE 7.1: The GICZ Executive will decide in consultation with the Head Coach of each zone team which roles will be filled for each zone team. GICZ Executive may choose not to fill all roles in each team if it does not see fit and have sole discretion on this decision with regards to payment.

NOTE 7.2: Coached Training Sessions will be paid at \$120.00 per zone team for a two-hour minimum session with a minimum of 7 players in attendance. A maximum of two sessions per team will be paid.

NOTE 7.3: If apparel is given to officials in previous seasons and they require new apparel, Greater Illawarra Cricket Zone reserves the right to charge officials for the purchase of new apparel.

Section 8: Training & Development & Administration Staff

The Greater Illawarra Cricket Zone has several training, development, and administration staff members to undertake a variety of task within its academy programs and clinics and such staff are remunerated for their services to the zone. Remuneration is of the form of an honorarium and are paid specified amounts as set by Country Cricket NSW, Cricket NSW, and GICZ Office Bearers / Executive Committee during the financial season. As a guide, the following honorariums are paid annually by GICZ or Cricket NSW to GICZ Staff if appointed and on completion of their duties:

- ❖ Zone Administrator \$ 11,500.00
- ❖ Zone Treasurer \$ 2,500.00
- ❖ Business Relations Officer \$ 1,000.00 + 10% of Zone Business Partnerships
- ❖ Female Cricket Representative: \$ 1,000.00
- ❖ Senior Representative Cricket Advisor: \$ 500.00
- ❖ Junior Representative Cricket Advisor: \$ 500.00

Section 9: Umpires Fees

Greater Illawarra Cricket Zone utilises registered cricket umpires within the Greater Illawarra area to officiate matches controlled and competed in by the Greater Illawarra Cricket Zone. The following governs the rate umpires will be paid for officiating matches held by Greater Illawarra Cricket Zone:

NOTE 9.1: For matches that do not commence, and an umpire has attended the ground prior to the scheduled start of play, the umpire will be paid \$30. If the umpire is required to wait at the ground for more than 1 hour after the scheduled start of play, the full fee will be payable.

NOTE 9.2: For matches where the umpires Representative is notified with not less than 180 minutes before the scheduled start of play, that a match is abandoned, no fee shall be payable to any umpire for that match. It is the responsibility of the Umpires Representative to notify any affected umpire.

NOTE 9.3: For other matches not listed, please contact the Greater Illawarra Cricket Zone Umpires Representative.

NOTE 9.4: All umpires are expected to be financial members of an umpire's association that is affiliated with a Zone cricket association. It is also preferred that all umpires be accredited NSWCUSA members.

Section 10: Attire and Uniform Fees

Players involved in Greater Illawarra Cricket Zone teams or academies may be asked to pay a levy or fee to cover the cost of or purchase their playing and training uniforms. This only applies to the Cricket NSW Zone Academy, Greater Illawarra Regional Academy, and NSWDCA/Youth Championships Competitions. In some instances, the training uniforms may be optional and if players have already purchased the uniform in one of the other Greater Illawarra programs, they will not be made to pay for it again. If the fee is included in the program cost, the below fee will be deducted from the overall cost of a program if the uniform is not needed.

Greater Illawarra Attire will also be made available for purchase to those willing to purchase. The following outlines the fees payable for the purchase of Greater Illawarra Cricket Zone Attire and Uniforms:

Section 11: Academy Fees & Honorariums

Players selected to participate in academies run by the Greater Illawarra Cricket zone will be subject to fees if they choose to take up the selection offer unless exemptions are sought due to extenuating circumstances such as financial difficulty. Greater Illawarra Cricket Zone offers Regional Academy programs to participants in the zone as selected. Fees for the academies are:

- ❖ CNSW Youth Academy (Former Zone Academy): Pay to CNSW (Not GICZ Academy)
- ❖ Male Regional Academies Junior (U13-U15): \$175.00, not including Uniform.
- ❖ Male Regional Academy Youth (U16-U21): \$200.00, not including Uniform.
- ❖ Female Regional Academy: \$150.00, not including Uniform.

Each Academy program also has a schedule for payment of honorariums to coaches of all regional academy programs. Payments are made at the following rates:

- ❖ Male Regional Academy Junior Head Coach: \$2,500.00 / season or \$250.00 / session
- ❖ Male Regional Academy Youth Head Coach: \$2,000.00 / season or \$250.00 / session
- ❖ Female Regional Academy Head Coach: \$2,000.00 / season or \$250.00 / session
- ❖ Male Regional Academy Junior Asst. Coach: \$1,800.00 / season or \$180.00 / session
- ❖ Male Regional Academy Youth Asst. Coach: \$1,440.00 / season or \$180.00 / session
- ❖ Female Regional Academy Asst. Coach: \$1,440.00 / season or \$180.00 / session

Section 12: Fines

Greater Illawarra Cricket Zone has stringent management ensuring that all administrative matters are undertaken in an exemplary and timely manner. As a result, the Zone Administrator at times may choose to impose financial penalties in the form of fines on individuals, players, team officials, match officials, clubs, or associations within the Greater Illawarra Cricket Zone for acts that impede the administrative matters of the zone, defame the zone, cause physical damage to facilities within the zone or its equipment, or for code of conduct matters (Refer to Greater Illawarra Cricket Zone Code of Conduct for more details).

Greater Illawarra Cricket Zone may decide to issue fines at a standard rate as listed below or at their own discretion. The following schedule outlines the fines payable:

NOTE 12.1: *Disputes and Judiciary Committee may impose any fine that it sees fit. The lodgement of a dispute, or lodgement of an appeal against any decision made by the Zone Judiciary Committee or Zone Administrator must be accompanied by a fee of **\$500**, which will be refunded if an individual or association is exonerated in each case.*
